Committee Descriptions

Village of Clifton, Illinois

Budget and Finance	The budget and finance committee shall oversee preparation of the annual budget and appropriations ordinance and shall review and make recommendations regarding all financial obligations of the village, including, but not limited to, insurance issues, utility contracts, major purchases exceeding \$10,000.00 not specifically assigned to another committee, and any other similar obligations. The budget and finance committee shall also recommend investment funds for village accounts. The village president may assign additional duties to the committee on an as-needed basis. Code 2-27(1)
Local Improvement	This committee shall oversee all village improvements not covered by another committee. Any issues pertaining to the village pool, village parks, village buildings and village easements shall be reviewed and recommended by this committee. This committee shall also be responsible for overseeing the operation of the village pool, including, but not limited to, repair, maintenance, manager, employees, licensing and all other issues relating to the village swimming pool. The village president may assign additional duties to the committee on an as needed basis. Code 2-27(4)
Ordinance and Zoning	The ordinance and zoning committee shall oversee all changes in ordinances and requests regarding zoning issues within the village. All requests by the planning commission shall be forwarded and reviewed by the ordinance and zoning committee, which shall review and make recommendations with regard to any petitions filed for rezoning, special use or annexation. The ordinance and zoning committee shall also review village ordinances and suggest modification as necessary or as requested by other committees. The village president may assign additional duties to the committee on an as-needed basis. Code 2-27(5)

Police and Public Safety	The police and public safety committee shall oversee the village police department and review and make recommendations with regard to any police department issues, including, but not limited to, hiring police, terminating police, purchasing police equipment, training of officers, complaints against officers and police vehicle maintenance. The committee shall also oversee maintenance of village storm sirens, police radios and other means necessary to ensure public safety. The village president may assign additional duties to the committee on an as-needed basis. Code 2-27(2)
Streets and Alleys	The streets and alleys committee shall oversee all village roadways, alleyways and sidewalks and review and make recommendations with regard to any issues relevant thereto, including, but not limited to, repair, maintenance, construction, abandonment, improvement and replacement of the roads, alleys or sidewalks. The streets and alleys committee shall also oversee and recommend all uses of motor fuel tax, including the annual maintenance contract and road improvement project. The village president may assign additional duties to the committee on an as-needed basis. Code 2-27(3)
Water and Sewer	The water and sewer committee shall oversee all issues pertaining to the village water system, sanitary sewer system, storm sewer system and drainage systems, natural and manmade, and review and make recommendations with regard to any issues relevant thereto, including, but not limited to, repair, maintenance, updating, replacement, hiring employees, terminating employees or construction of the systems or their components. The village president may assign additional duties to the committee on an asneeded basis. Code 2-27(6)
