Plumbing Permit:\$200 for all new residential homes and \$80 for each additional unit in a multi-family unit.

- \$80 for all other residential plumbing work (addition, garage, in-ground pool)
- \$200 for all commercial work (new, addition, remodel)
- \$80 for any additional inspections or reinspection's

SITE PLAN REVIEW FEES:

For projects having development costs and/or building costs totaling up to \$1,000,000, a fee of one-fifth of a percent (1/5%) of the cost of the property improvements.

For projects having development costs and/or building costs totaling over \$1,000,000, a site plan review fee of \$2,000 plus \$500 per million dollars or part thereof the cost of the property improvement over \$1,000,000.
